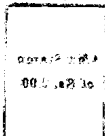

***To be signed by any one of the following persons :-**

- (1) A Government servant of Sri Lanka in receipt of a salary of not less than Rs. 7,500 p.a. or a Government pensioner of Sri Lanka whose salary at retirement was not less than Rs. 10,020 p.a.
- (2) A member of the Foreign Service of Sri Lanka in receipt of a salary of not less than Rs. 7,500 p.a.
- (3) A Commissioned Officer of the Army, Navy or Air Force of Sri Lanka.
- (4) A Notary Public or other person authorised to administer oaths in the territory in which the Certificate is given.
- (5) A Barrister, Solicitor or Advocate authorised to practise in the territory in which the Certificate is given.
- (6) A Physician or Surgeon registered as such under the law of the territory in which the Certificate is given.
- (7) An Officer of a bank who is authorised to sign documents on the bank's behalf.
- (8) A Justice of the Peace.
- (9) A Magistrate.
- (10) A Chartered Accountant.
